- ii) The Tax Audit for the AY 2025-26 shall be completed on or before 30.09.2025 and then ITR should be filed within 30 days from the date of tax audit filed in portal or before 31.10.2025 and the tax audit report should be submitted to Head Office of the Bank.
- iii) Payment shall be made either through NEFT/RTGS or A/C payee cheque only.
